This scheme will be open to general public, animal lovers, corporate section, celebrities, educational Institutions etc.

Adoption of Zoo animals would help the zoos in involving conscious and esteemed people and companies in bringing more awareness about the plight of the endangered species. It shall be benefited by adopter's interest towards conservation of animal wealth of our globe, the contribution would assist in improving the existing overall facilities for the animals and ultimately for their better care and conservation in the zoos.

A Zoo gets in an Animal Adoption scheme when the Zoo has enough credibility, commitment and confidence in handling and keeping the animals in its care. This is because that this scheme would need a lot of responsibility on the part of the Zoo staff.

By adopting one's your favorite animal, the person/firm/organization will contribute towards feeding of the animal and provide help in efforts in Wildlife Conservation. Zoos are involved in captive projects, all of which need support from civil society as well.

Thus, by adopting the animal the individual/Company/Business unit will not only express his/her/their love for the animal but also inspires others to follow his/their footsteps. An adoption makes a great gift for birthdays, anniversary, in remembrances etc and is always something unique.

### PROCEDURE FOR ADOPTION:

- Pick your favourite animal from the list of zoo animals.
- Choose a level of Adoption (Monthly/Half yearly/Yearly)
- Fill in the attached Adoption Form and submit it in the Office of the Additional Director, Jambu Zoo along with receipt/proof of amount deposited for adoption of the animal.
- The adopter shall be provided with an animal adoption certificate by the department on completion of adoption period.

### Terms and Conditions of Adoption:

1. Any interested person or party interested to adopt animal voluntarily can choose animals in which the adopter is interested and pay for their care, by entering into an agreement (Annexure I) with zoo management after filling up the application form (Annexure III).
2. Payment may be paid by **Account Payee Cheque, Demand Draft, Online transfer, Credit or Debit card to the Jambu Zoo, Official Account Number-0537010200000104 in J&K Bank, Branch New Plot, Jammu.** No cash will be entertained.



3. Renewal of adoption can be made by auto renewal system against credit card or debit card with applicable renewal charges.
4. Renewal can be made by e-mail to the Department.
5. Adoption scheme is person/firm/organization specific and it is neither transferable nor refundable.
6. Adopter details except those displayed or published shall be kept confidential and shall not be shared with other organizations without prior permission of the concerned adopter.
7. If approached by the media on any Zoo information, he/she should refrain from answering any questions or sharing his/her opinions on a Zoo matter, unless it has been previously approved by the Zoo management.
8. Adoption of zoo animals will be for monthly, half yearly and yearly basis. The adopter may withdraw his/her adoption at any time. But in that case, no money will be refunded.
9. The adopter may select the animals for adoption as per the rates provided in Annexure-II
10. Adoption will be terminated, if any misconduct, misbehavior, misuse of the adoption is observed, adopter found criticizing zoo management in public/on any social platform, found sharing/seeking any management information through any mode to anyone to interference in the management/defaming the zoo/authority, violation of any of the condition of the agreement or any criminal case is pending against adopter in the court of law or submit any false information. No claim of refund will be entertained.


#### **BENEFITS TO BE GIVEN:**

1. The adopters shall be invited as special guest during various celebrations in the zoo.
2. On completion of the adoption tenure, the adopter will be provided with Animal Adoption Certificate by the department.
3. The adopter can enjoy peace of mind being associated with Jambu Zoo for conservation of our country's rich heritage.
4. Adopter name/company logo will be featured in a signage of size 2`x1.5` (Annexure IV) in front of the adopted animal enclosures during the period of adoption, so that his/her or company's name can also reach thousands of zoo visitors.
5. The noble efforts of the adopter will certainly help the department in Wildlife Conservation.

Lastly it's joy and pride of taking care of an animal species, which we know are in need of conservation & protection, so that future generations can also see them.

## ANNEXURE I

### AGREEMENT FORM FOR ADOPTION OF ANIMALS



This agreement is made this \_\_\_ day of \_\_\_\_\_ between the Jambu Zoo, Jammu, Jammu (Jammu Zoo) represented by its Director/ Addl. Director or the authorized representative and hereinafter called the first Party of the One Part.

AND

WHEREAS a programme for the adoption of mammals/ birds/ reptiles has been launched by the First Party and under the said programme any mammal or bird or reptile housed in the aforementioned Jambu Zoo, Jammu, Jammu may be adopted by corporate houses or individuals or any interested entity.

AND WHEREAS this programme has been initiated so that the people can participate and involved in the welfare of the mammal/bird/reptile; and mammal/ bird/ reptile lovers intending to look after the needs and welfare of the mammals / birds / reptiles may adopt any mammal or bird or reptile.

AND WHEREAS the Second Party being desirous of adopting a mammals/ birds/ reptiles has entered into an agreement to adopt a mammal/ bird/ reptile with the First Party on the following terms and conditions :

Now the agreement witnesses

1. That the money required for the cost of aforementioned animal/ bird/ reptile is being paid by the Second Party to the First Party vide Cheque No./DD No. / Online Payment Transaction details/ UTR No. \_\_\_\_\_ Dated & Time \_\_\_\_\_ Amount in Rs. \_\_\_\_\_ (in words) (Rupees \_\_\_\_\_ only).
2. That the First Party has acknowledged the payment of Rs. \_\_\_\_\_ (in words) (Rupees \_\_\_\_\_ only) by Receipt No. \_\_\_\_\_ dated \_\_\_\_\_.
3. That this agreement for adoption shall remain valid, binding and operative for only the period mentioned above that is from \_\_\_\_\_ agreement is executed. to \_\_\_\_\_ and shall commence from the day this
4. That the expiry of the agreement period as stipulated, the Second Party may enter into a new agreement with the First Party. The rates of the adoption charges and other new provisions, if any, of the agreement shall be decided



by the First Party.

5. That this agreement shall not entitle, for any purpose whatsoever, the Second Party of his/her familymembers to feed, touch, handle, fondle or carry any animal/ bird/reptile outside its enclosure nor shall it entitle the Second Party or his/her family members to enter the enclosure/kraal/den of the animal/ bird/reptile or do such other act which violates the animal laws and Wildlife Protection Act - 1972.
6. That however the Second Party shall neither insist on visiting the Zoo during non-visiting hours/visiting den/kraal area nor shall he/she claim any other facilities and amenities from the first party apart from those stipulated in this agreement.
7. That the First Party shall put up a board outside the enclosure of the adopted animal/ bird/reptile exhibiting clearly the name of the Second Party and illustrating that the particular animal/bird/reptile has been adopted by him/her for the period from\_\_\_\_to\_\_\_\_. The dimensionof the board shall not exceed 2' x 1.5' in any case. In case of adoptions of different animals of thesame species housed in same enclosure the information will be clubbed together on the same board.
8. That the First Party shall grant a certificate to the Second Party showing the details of the animal/ bird/ reptile adopted by him/ her.
9. That the Second Party shall not claim any right over the ownership of the adopted animal/ bird/ reptile or its offspring or for any part/ parts of any animal/ bird/reptile.
10. That on the death or exchange (with some other zoo) of the adopted animal/ bird/ reptile before the expiry of the stipulated period of the agreement, the money which had initially been paid by the Second Party as adoption charge shall be forfeited to the First Party and the Second Party shallnot be entitled to refund of the same nor shall the Second Party be entitled to adopt some other animal/ bird/ reptile with the initial adoption charge paid by him/ her.
11. That if the Second Party intends to terminate the agreement before the expiry of the period as aforementioned, the Second Party shall give one month's prior notice in writing to the First Party and shall thus be entitled to terminate the agreement. However, in such case, the Second Party notis entitled to refund of the adoption charge paid by him/ her.
12. That the Second Party, shall not, in any way, interfere in the management and administration of the First Party. All management practices resets solely in hands of the First Party and all management andadministrative decisions shall be taken by the First Party.
13. That in any case of any minor disputes and differences that will be settled between both the parties mutually and amicably. Decision of the Director/Addl. Director, Jambu Zoo will be final.

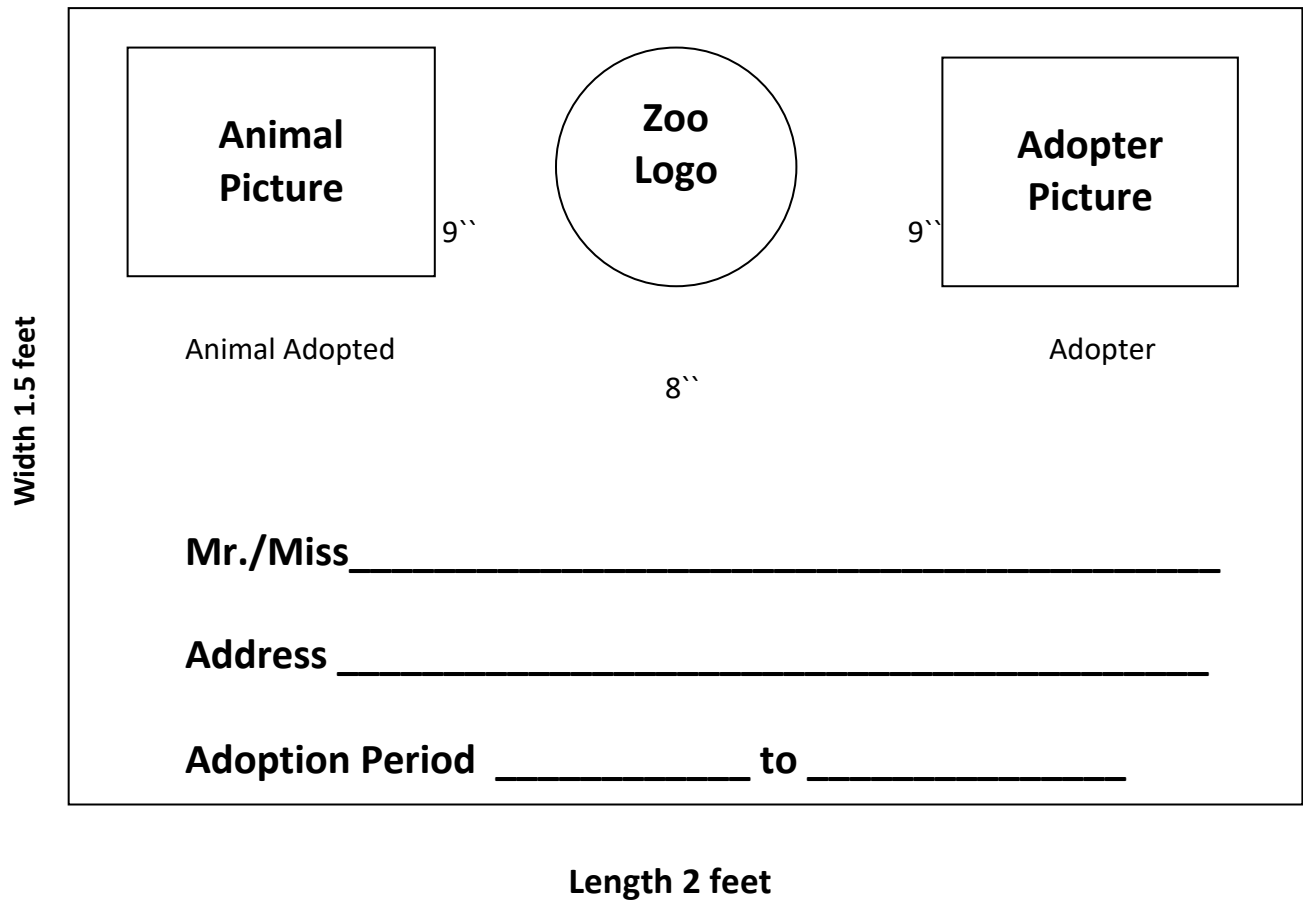
